## Long Live the Lazy Sweepstakes/Instant Win

## **OFFICIAL RULES**

NO PURCHASE NECESSARY. NEITHER A PURCHASE NOR PAYMENT OF ANY KIND WILL INCREASE YOUR CHANCES OF WINNING. INTERNET ACCESS REQUIRED.
